Church Delegate Nomination Process and Form

Action Steps

- The local church Eldership or Board must formally endorse the nomination of the person mentioned here as its church Delegate and ensure that the endorsement appears in their formal record of meeting (or minutes).
 The endorsement will also be expressed below via the "Supporting Senior Minister/Minister" and "Supporting Elder/Board Member/Other Minister" sections.
 Where there is no Eldership or Church Board, the National Executive will endorse the nomination in partnership with the relevant State Executive.
- The nominee completes his/her details below to apply for recognition as their local church's Delegate.
- If the nominating person IS NOT a credentialed CRC Minister then they also must complete a "Church Delegate Application Form" AND they must have <u>two people</u> complete a "Church Delegate Referee Form" to support their application.

One of these referees must be the <u>Senior Minister</u> of their church OR where there is no Senior Minister, it must be a <u>credentialed CRC Minister holding a National or State credential</u> **AND** the other referee should be an <u>Elder/Board member who is not a relative of the</u> <u>applicant.</u> Where there is no Eldership or Church Board, the second referee should be <u>another credential CRC Minister</u>.

- 4. If the nominating person IS a credentialled CRC Minister (State, Affiliate or Trainee), they only need to complete <u>this form</u>. They DO NOT need to complete the "Church Delegate Application Form" AND they DO NOT need to have two people complete a "Church Delegate Referee Form" on their behalf as this process was covered during their credentialing process.
- 5. If the nominating person holds a National Minister's Credential, no application to be a church delegate is necessary because this person already is a voting member of the National Council.
- 6. Once this form has been completed, it should be forward to the National Office of CRC Church International (along with Church Delegate Application Form if required) via email to admin@crcchurches.org or via mail to 185 Frederick Road, Seaton SA 5023.
